
# 2024 Health Equity Innovation Awards



#### **2024 Health Equity Innovation Awards**

We are excited to announce the 2024 Health Equity Innovation Awards and the focus on addressing health disparities and improving health equity.

- Requests for funding can be up to \$30,000 to qualified community-based organizations, located within the health plan region, through a competitive process available online at UniveraHealthcare.com/Community.
- Awards will be given to community partners that show dedication to reducing health
  disparities and improving health equity among underserved populations affected by racial,
  ethnic, disability, gender, and rural disparities, including but not limited to mental health and
  maternal health. This includes efforts to improve physical and mental health, decrease social
  inequalities in healthcare, and guarantee access to healthcare.

#### **Application rules and requirements:**

Nonprofit 501(c)(3) organizations within Univera Healthcare's service area are eligible to apply for the Health Equity Innovation Awards. We seek proposals for innovative initiatives or projects that have demonstrated success in reducing disparities, have the potential for expansion, and include clearly defined goals for reducing health disparities and improving health equity.

Health Equity Innovation Award priority areas are:

- Improved Maternal Health Outcomes
- Behavioral Health or Mental Health Conditions
- Acute and Chronic
   Disease Management

 Social determinants of health such as economic stability; education access, and quality; health care access and quality; neighborhood and built environment; and social and community context

#### Submit an application:

The Health Equity Innovation Award application focuses on organization and program information, and intended impact.

 Application portal will open: Thursday, September 5, 2024 at 10:00 a.m. and close at 11:59 p.m. on Friday, October 4, 2024.

#### **Review process and notification:**

- Applications will be reviewed by the Health Plan and decisions announced by the end
  of November. We will prioritize proposals that have detailed scope, goals, rationale for
  support, and measures.
- Univera Healthcare will follow up with recipient organizations six months after funding is received to understand impact and use of funds.

### Univera Healthcare's partnership with The Foundation for Western & Central New York

Univera Healthcare is accepting applications from community-based organizations for its 2024 Health Equity Innovation Awards, which provide funding aimed at supporting health and wellness programs that address racial and ethnic health disparities in Western New York.
